THE IMPORTANCE OF THE U.S. MARKET




- The United States is one of the world's largest food importers, with total food imports reaching \$211 billion in 2024. In 2023, the U.S. imported \$191 billion worth of food, accounting for 10% of global food imports.
- In 2024, the United States maintained its position as the world's largest economy, with GDP reaching \$29.18 trillion—an increase of \$1.46 trillion compared to 2023. The GDP per capita rose to \$87,081, up by \$4,366 from the previous year, reflecting overall economic growth and rising income levels. The U.S. population was estimated at 341.6 million, which constitutes approximately 4% of the global population, with the total world population standing at 8.11 billion.
- Recent changes in U.S. tariff policy—reaching up to 125% on Chinese products, while excluding several electronic goods such as smartphones, flat-screen televisions, and computers—have created new opportunities for other exporters to enter or expand their presence in the market. While China exports around \$6 billion in food products to the U.S.,
- Egypt's food exports to the American market remain relatively low at \$321 million, revealing a significant untapped potential. Egypt has the opportunity to increase its market share, especially in categories where it holds competitive advantages and where Chinese products are now facing higher trade barriers.










U.S. IMPORTS OF FOOD PRODUCTS FROM CHINA (2015–2024 IN BILLION USD

HS Code **151800** Animal or Vegetable fats and oils is a broad category that includes several detailed subheadings, such as:


■1518004000 – Animal and vegetable fats and oils and their fractions, boiled, oxidized, dehydrated, sulfurized, etc.

This product saw a sharp increase in U.S. imports from China, rising from \$794 million in 2023 to over \$1.19 billion in 2024.

■1518002000 — Inedible mixtures or preparations of linseed or flaxseed oil, NESOI

Although more niche, this product recorded \$1.7 million in U.S. imports from China in 2024

YEARLY GROWTH TREND FROM EGYPT TO USA (2014-2024)



Egypt's processed food exports to the U.S. represent 5% of its \$6.1 billion food industry exports, making the U.S. the fourth-largest importer. In 2024, 326 Egyptian companies exported to the U.S., with 62 of them accounting for 87% of the total export value (\$287) million).


According to GOEIC data, Egypt's exports under HS Code 03 (Fish and Crustaceans) include the following key products, which together represent \$30.5 million out of a total of \$31 million in fish exports:

- •HS 030611 & 030612: Frozen freshwater and rock lobsters (استاکوزا المیاه العازیة) (Homarus spp., Palinurus spp., Panulirus spp., Jasus spp.) \$29.23 million
- •HS 030912: Live eel (Anguilla spp.)

(ثعبان البحر) – \$647 thousand

•HS 030431: Fresh or chilled tilapia fillets (Oreochromis spp.) (السمك البلطي) - \$695 thousand

- This analysis identifies overlapping products (HS codes) that the U.S. imports from China, and compares them with Egypt's export to the U.S. in the same product categories.
- The goal is to highlight high-potential products where China currently dominates, but where Egypt already exports or has the capacity to enter.
- The analysis is based on:
 - U.S. import data by product and origin (from ITC Trade Map).
 - Egypt's export data to the U.S. in 2024 (GOEIC).
- This helps identify opportunities for Egypt to increase exports to the U.S. in products where China may face higher tariffs or trade barriers.

Note: A value of 0 in Egypt's export data indicates that, according to GOEIC records, this HS code was not exported to the U.S.in 2024.

Updates on QIZ Agreement and GSP Program Status

Background on QIZ:

The QIZ agreement, signed in 2004, allows Egyptian products tariff-free access to the U.S. market if they include a 10.5% Israeli input.

Generalized System of Preferences (GSP) Overview:

The U.S. GSP program historically provided duty-free tariff treatment for eligible products from developing countries, including Egypt.

The GSP program officially expired on December 31, 2020.

 Although CBP instructed importers to continue flagging GSP-eligible shipments for possible retroactive refunds if Congress reauthorizes the program, no legislative action has reinstated its full benefits.
